**Notice Concerning the Status of the Acquisition of Treasury Stock**  
**(Acquisition of Treasury Stock Based on the Articles of Incorporation**

JAPAN POST INSURANCE Co., Ltd. (hereinafter the “Company”) announces the status of the acquisition of its treasury stock notified on August 10, 2022, as described below. The acquisition was implemented pursuant to Article 39, Paragraph 1 of the Company’s Articles of Incorporation complying with Article 459, Paragraph 1, Item 1 of the Companies Act.

1. Class of shares to be acquired: Common stock of the Company
2. Total number of shares acquired: 1,080,500 shares
3. Total amount of shares acquired: 2,347,953,700 yen
4. Acquisition period: From November 1, 2022 through November 30, 2022 (contract basis)
5. Method of acquisition: Purchases through trading on the auction market of the Tokyo Stock Exchange, Inc.
